The Trust's Research Function's overall purpose is to improve health outcomes, services, and treatments for our patients.

Our teams help to develop new treatments and technologies, improve patient care, and make the health and social care system more efficient by running individual trials or collaborating with other providers in multi-site trials.

 - Genetic data
 - Health data
- D. Where we receive personal information from
 - Directly from you
- E. How long we keep research information
 - No longer than 30 years
- F. Your Data protection rights
 - Your Rights that are Applicable
 - Your right of access You have the right to ask us for copies of your personal information.
 - Your right to rectification You have the right to ask us to correct or delete personal information you think is inaccurate or incomplete.
 - **Your right to object –** You have the right to object where the legal basis is a task carried out in the public interest or the exercise of official authority.
 - o Your right to restriction of processing You have the right to ask us to limit how we can use your personal information.
 - The rights which are NOT applicable
 - Right to erasure
 - Right to portability
