

# **INDEPENDENT AUDITOR'S REPORT TO THE COUNCIL OF GOVERNORS OF NORFOLK AND NORWICH HOSPITALS NHS FOUNDATION TRUST**

## **AUDIT COMPLETION CERTIFICATE**

In our audit report dated 24 June 2025 we stated that we could not certify that we had completed the audit of Norfolk and Norwich Hospitals NHS Foundation Trust ("the Trust") for the year ended 31 March 2025 in accordance with the requirements of Schedule 10 of the National Health Service Act 2006 and the Code of Audit Practice published by the National Audit Office (the "NAO") in November 2024 on behalf of the Comptroller and Auditor General (the "Code of Audit Practice").

We could not certify completion at 24 June 2025 because at that date we were unable to confirm that we had completed our work in respect of the trust accounts consolidation pack of the Trust for the year ended 31 March 2025 because we had not received confirmation from the NAO that the NAO's audit of the Department of Health and Social Care's accounts was complete.

Following receipt of the confirmation from the NAO that the NAO's audit of the Department of Health and Social Care's accounts is complete, we have now completed our work in respect of the trust accounts consolidation pack of the Trust for the year ended 31 March 2025.


No matters have come to our attention since the date of our audit report, 24 June 2025, that would have had an impact on our reporting by exception on whether we had identified any significant weaknesses in the arrangements that have been made by the Trust to secure economy, efficiency and effectiveness in its use of resources.
